

## **Love Amplified Official Contest Rules**

The Love Amplified contest Winner and the Winner's guest must both be a U.S. resident eighteen (18) years or older. Social media participants may make nominations as many times as they choose. Employees, officers, directors, agents, representatives, and immediate family and household members of the GMA Foundation, Inc., Gospel Music Association Trade Organization d/b/a as GMA, Inc. and their designees (collectively "the GMA") and their advertising and promotion agencies are not eligible to participate in the contest.

There will be one (1) Winner selected by September 11, 2016 from among all eligible entries posted on social media between August 7, 2016 and September 11, 2016 ("Entry Period"). The Winner will be determined by the GMA staff and other music professionals selected by the GMA staff (collectively "Contest Judges") based solely on the Contest Judges opinion. The Winner and Winner's guest must complete an affidavit of eligibility and liability and a publicity release. If GMA does not receive the affidavit and release within two (2) weeks of notification, the prize may be forfeited and an alternate winner may be selected. Except where prohibited by law, by signing the affidavit and release, the Winner and Winner's guest shall each grant permission to the use of his/her/its name, likeness, picture, portrait, hometown, service mark, voice, biographical/other information, and statements for advertising and promotional purposes for this and other promotions by the GMA without additional compensation. Odds of winning depend on the total number of entries posted.

There is one (1) Prize: Round trip airfare transportation for the Winner and one guest to attend the Dove Awards in Nashville, TN, leaving together on October 10, 2016 and returning to their single home city on October 12, 2016 (excluding transportation between Winner's and guest's homes and the gateway airport) and two (2) nights of hotel accommodations in one room (3 star or better) for the Winner and one guest, ground transportation in Nashville for the Winner and guest, plus two \$100 American Express or Visa gift cards to be used by Winner and guest towards meals with a total maximum retail value of \$1,500.00.

No transfer, substitution, or cash equivalent will be given for the Prize. By participating in the contest, each entrant and nominee agrees to abide by and be bound by all of these official contest rules and the decisions of the Contest Judges. All decisions regarding the contest including, but not limited to, selecting the Winner, will be made by the Contest Judges, whose decisions shall be final. The Contest Judges may prohibit a nominee from participating in this contest, in his/her sole discretion, if, in the opinion of the Contest Judges, the nominee fails to abide by these rules, or otherwise acts (i) in a non-professional or inappropriate manner, (ii) with an intent to annoy, abuse, threaten, or harass any other entrant, judge, or GMA staff, or (iii) in any other disruptive manner. The Winner and the guest shall each be solely responsible for all applicable federal, state, and local taxes. All federal, state,

and local laws apply.

By participating in the contest, each entrant and nominee agrees to release and hold the GMA, harmless from any and all losses, damages, rights, claims, and actions of any kind in connection with the contest or resulting from acceptance, possession, or use of any prize, including, without limitation, personal injuries, death, and property damage, and claims based on any libel, slander, illegal competition or trade practice, violation of rights of privacy, infringement or copyrights, or other rights of third parties.
